Actions that would make a difference	Who is working on it?
Offering more mental health resources	The primary focus of Valley Oaks Health is mental health and substance abuse. They provide individual and family therapy, some marriage counseling, school-based programming for kids in school and outside of school, home and school-based case management services, and substance abuse counseling. There is a higher need for substance abuse counseling. They work with probation and juvenile probation and have prescribers that specializes in addiction medication. They offer Telehealth and have different providers, including psychiatric and nurse practitioners for addictions, youth, adults, Naltrexone and Suboxone.  Family Health Clinic offers behavioral health, psychiatric and pediatric services. They have referral relationships with Four County and Valley



They are working on adding a social worker into the schools to help to counseling. They offer a Vivitrol program for individuals with substance abuse and mental health concerns. This program is in White County, also. They have had more success with alcohol than substance abuse "We see people on the ground who don't even realize they have nee that we can help with." Offering more wrap-around services for schools and families	Valley Oaks has wrap around services.

Creating transitional facilities	Nothing is actively being done.

Eliminating Recidivism (study other successful models)	<u>Valley Oaks</u> is looking at other models that are working in Indianapolis and Fishers to reduce recidivism. They would like to apply what they learn in Carroll County.
	Law Enforcement is seeing the same offenders over and over.
Re-engaging offenders into the community	They are trying to support this transition but are at a stand-still right now.

### Additional Notes from Research Sessions for the Community Foundation's Reference:

We asked each member of the group where the community foundation could make the most impact regarding this aspiration?

- Mental health touches all areas and substance abuse is mental health. Having a coordinator that ties all of these facilities and resources together in the county would help. Find the time to understand how it can be done here.
- Transportation for access to services is huge.
- There are no shelters, services, or transitional pieces for domestic violence or PTSD.
- People need food, safety, and shelter. There is an essential need for a homeless shelter and food pantries.
- They need transitional housing and shelters.
- There is a need for addiction services and mental health treatment in the jail.
- They need better training for law enforcement about mental health and the resources available in the community
- They need a coordinator that works with the county, a "hub" or "center" that helps manage and implement all the services in the county.

#### Discussion on:

- If all 3 counties agreed this was something we could work on, there could be a lot of help from Howard and Clinton.
- Lilly would probably like a coordinated effort in a grant application.
- Sherry Rahl and/or Paul Wyman would be willing to come and talk with this county about Turning Point and what they are doing.
- Greg shared that in Howard County we brought up the idea of holding a Summit or SWOT-type gathering of the
  experts and people with boots on the ground in this area. The purpose is to get them to tell us what they need or
  would like us to do.
- Acknowledged that we are such a grass roots community, that we need to be careful in keeping our local leaders across the county engaged and informed in this process, so they are respectfully involved.
- Greg went over the March 13th deadline for grant application processes. We need to know what we want to do in February.
- The diversity of these three counties in workforce demographics is a good selling point.
- We need to make sure we examine good models.
- Touched on how these issues affect the workforce. Greg discussed the One80 Program in Clinton County. Goal is
  to get people the help they need so they can get back into the workforce. Jake has met with Judge Menges in
  Kokomo and, instead of work release, they are sending clients to classes to get them certified in skills.
- There is still a stigma from being in jail that results in not being able to get a job afterward. Transportation issues keep people from getting to work and accessing services.
- Central hub of services and a navigator/coordinator may be needed.
